# **PGY2 Critical Care Learning Experience Descriptions**

# **Required Learning Experiences**

# Cardiovascular Critical Care

Required, 1 month

Kyle Dillon, PharmD, BCCCP Rebecca Rich, PharmD, BCCCP, FCCM Michael Semanco, PharmD, BCPS, BCCCP, FCCM The Cardiovascular Critical Care experience will provide the resident an opportunity to develop the pharmacotherapeutic skills necessary to care for critically ill patients with cardiovascular disorders. The rotation will take place in the 18-bed Surgical ICU focusing on medical and surgical cardiovascular disorders. Patient care and assigned topics will include ACS (STEMI and NSTEMI), atrial arrhythmias, ventricular arrhythmias, cardiogenic shock, and the treatment of acute decompensated heart failure. The resident may be given the opportunity to observe procedures in the cardiac catheterization lab and the cardiovascular operating room (CVOR).

# **Emergency Medicine**

Required, 1 month

Kayla Wilson, PharmD, MS, BCPS, BCEMP Megan Nguyen, PharmD, BCEMP Heather Schucker, PharmD, BCEMP Natalia Figueroa, PharmD, BCEMP The Emergency Medicine experience will develop clinical pharmacy skills needed to treat patients in a variety of areas while providing experience and more specialized education on the care of Emergency Department (ED) patients. The resident will be assigned a specific area within the ED where they will be expected to round regularly to identify and resolve pharmacy related issues. Opportunities to participate in trauma, stroke, and STEMI alerts as well as both adult and pediatric cardiac arrests will be available.

#### **Infectious Diseases**

Required, 1 month

The Infectious Diseases experience will provide the resident an opportunity to develop and refine the pharmacotherapeutic skills related to the identification and treatment of less common infectious diseases. The resident will be required to identify and assess all anti-infective therapies and provide appropriate recommendations to optimize the care of assigned patients. The resident will be given the opportunity to round with an Infectious Diseases physician and to participate in regular topic discussions.

# **Medical Critical Care**

Required, 1 months

The rotation will focus on the provision general medical critical care, for a variety of patients and disease states including sepsis, diabetic ketoacidosis, and many others. This experience is intended to provide the resident an opportunity to develop and refine the pharmacotherapeutic skills necessary to care for a variety of critically ill patients.

## **Medical Critical Care II**

Required, 2 months

The rotation focuses on precepting an APPE student for their Critical Care rotation, in addition to providing general medical critical care. This experience is intended to provide the resident an opportunity to develop and refine the pharmacotherapeutic skills necessary to care for a variety of critically ill patients and facilitate learners' experiences.

#### **Neurocritical Care**

Required, 1 month

Kyle Dillon, PharmD, BCCCP Rebecca Rich, PharmD, BCCCP, FCCM Michael Semanco, PharmD, BCPS, BCCCP, FCCM The Neurocritical Care rotation will provide the resident an opportunity to develop the pharmacotherapeutic skills necessary to care for critically ill neurologic patients. The rotation will take place in the 18-bed Neuro ICU and focus on neurocritical care. The resident will care for patients with a variety of neurologic issues, including stroke, post-surgical patients, status epilepticus and more. The experience will provide the resident an opportunity to develop and refine the pharmacotherapeutic skills necessary to care for a variety of critically ill patients.

#### Orientation

Required, 3 weeks

Orientation will provide the resident exposure to the decentralized pharmacy practice model, including established clinical activities and the medication distribution process. The resident will receive training on the electronic health record (Cerner). While rotating through the Pharmacy department, the resident will have an opportunity to work with various members of the pharmacy staff. The resident will also have the opportunity to shadow members of the critical care team. The resident will participate in various clinical topic discussions as well as begin working on the required MUE and research projects.

# Trauma Critical Care

Required, 1 month

The rotation will take place in the 18-bed Trauma ICU and focus on general trauma management. This experience will provide the resident an opportunity to develop and refine the pharmacotherapeutic skills necessary to care for a variety of critically ill patients.

# **Trauma Intermediate Care**

Required, 1 month

The Trauma Intermediate Care experience will provide the resident an opportunity to develop the pharmacotherapeutic skills necessary to care for trauma patients. The rotation will take place in the 29-bed Trauma Stepdown unit and focus on general trauma management and transitions of care. This experience will provide the resident an opportunity to develop and refine the pharmacotherapeutic skills necessary to care for a variety of trauma patients.



# **Surgical Critical Care**

Required, 1 month

Kyle Dillon, PharmD, BCCCP Rebecca Rich, PharmD, BCCCP, FCCM Michael Semanco, PharmD, BCPS, BCCCP, FCCM The Surgical Critical Care experience will take place in the 18-bed Surgical ICU. The focus will be to further refine skills in caring for critically ill surgical patients in addition to learning different aspects in caring for the surgical patient. Topic discussions will focus on various surgical interventions. The resident will be given opportunity to observe cases in the OR when able.

# **Required Longitudinal Learning Experiences**

#### Code 99

Required, longitudinal 12 months

Assigned Code 99 Advisor

The Code 99 longitudinal experience will require the resident to actively participate within the multidisciplinary code response team. The resident is expected to participate in a variety of roles throughout the year, including medication preparation and dispensing, chest compressions, recorder, problem solver, or any other role that does not require specific licensure. Additionally, the PGY2 Critical Care resident is expected to act as a mentor to the PGY1 residents during Code 99 response.

#### **Presentations**

Required, longitudinal 12 months

**Assigned Presentation Advisor** 

The Presentations longitudinal experience will provide the resident an opportunity to formally present pertinent topics in multiple formats to various members of the multi-disciplinary team. The purpose of these presentations is to educate other members of the healthcare team, learn how to present to professionals with a variety of expertise and healthcare experience, and gain confidence in public speaking. The resident is required to formally present once each quarter to the healthcare team, including physicians, nurses, respiratory therapists, and/or pharmacists. Additionally, a one hour continuing education presentation (seminar) is required.

# **Professional Development**

Required, longitudinal 12 months

Selected Residency Advisor

The Professional Development longitudinal experience will foster the professional evolution and personal progression of the resident through a variety of non-patient care related activities. This experience will provide the resident opportunities to learn how to positively contribute to their own development as well as contribute to the healthcare system as a whole. The resident is required to present a P&T monograph or drug class review, participate in P&T and ICU Committee meetings, actively participate in the recruitment and selection of the next PGY2 Critical Care resident, and complete the PGY2 Critical Care Pharmacy Resident Topic Review List.

## Research / Quality Improvement

Required, longitudinal 12 months

Assigned Residency Advisor

The Research longitudinal experience will require the resident to complete an MUE and formal research project through the course of the year. The resident is the primary investigator and responsible for developing the research idea, obtaining IRB approval, data collection and analysis, and drawing conclusions with the assistance of research advisors. A poster presentation of the MUE results is taken to the ASHP Midyear Clinical Meeting. The research project results are presented at the Florida Residency Conference (FRC). Both projects are also presented at the pertinent LRH committees. A manuscript (MUE or research project) is prepared for publication prior to the completion of the residency year.

#### Staffing

Required, longitudinal 12 months

Assigned Residency Advisor

The Staffing longitudinal experience allows the resident to provide complete patient care as a decentralized unit-based pharmacist. The resident will work 11 weekends a year (Saturday and Sunday 0700-1930) and one major holiday. The resident will be responsible for verifying orders, providing pharmacotherapy consult services, ordering & monitoring TPNs, responding to Code 99s, resolving physician & nursing medication problems, and being present as a drug information resource. In addition, the resident is expected to review all patients' medication profiles and pertinent history in an effort to optimize outcomes by proactively intervening on patient medication issues.

# **Elective Learning Experiences**

#### Administration

Elective, 2-4 weeks

Administration is an elective 2- or 4-week experience providing exposure to critical care pharmacy management. This rotation is designed to enhance the resident's skills as an effective leader in the critical care environment. The resident will be assigned various projects throughout the rotation based on the needs of the department and the resident's interests. The resident will work with the preceptor to gain knowledge of the order set development and maintenance process. The resident may be assigned residency learning experience descriptions, manuals, and schedules to review and update in order to prepare for the incoming residency class. The resident may attend various hospital committee meetings with the preceptor.



#### **Informatics**

Elective, 1 month

The Informatics experience will expose the resident to the organization's medication-use systems by applying pharmacy informatics principles, standards, and best practices. The resident will gain a basic understanding of the language and concepts of information technology and learn how these concepts apply clinically. They will also be exposed to the EHR, CPOE, pharmacy information system maintenance, integration of automated dispensing cabinets, decision support, ADR surveillance, and integration of medication management systems that enable bar code medication administration and use of "smart" infusion pump technology.

#### Pain management

Elective, 1 month

The Pain Management experience will provide an opportunity for the resident to develop and refine assessment and pharmacotherapeutic skills as related to the treatment of acute and chronic pain. The resident will gain exposure to a variety of pain conditions including acute postoperative pain, trauma-related pain, chronic pain syndromes, and pain complicated by the presence of substance abuse.

#### **Psychiatry**

Elective, 1 month

The Psychiatry experience takes place at the Harrell Family Center for Behavioral Wellness, a 96-bed facility that offers both inpatient and outpatient treatment for age 10 and older for a variety of behavioral health conditions. The experience is designed to develop and further refine the resident's skills in pharmacotherapy, drug information retrieval and evaluation, verbal and written communications, patient monitoring and education as they apply to the psychiatric patient. Although the learning experience is not specific to critically ill patients, the resident will learn concepts and skills that will be directly applicable to the care provided to critically ill patients in the intensive care units.

# Intensification of Required Learning Experience

Elective, 4 weeks

Preceptor - TBD

The resident may choose to intensify any required or elective rotation as an additional elective experience. These experiences will be developed at the discretion of the resident and will be highly tailored to the specific needs / requests of the resident. The experience may vary in length but will be at least two weeks in duration.
